Bipartisan backlash to Biden's ultimatum on Israeli offensive

Biden withholding bombs and artillery shells deemed indiscriminate, imprecise

President Joe Biden finds himself at the centre of bipartisan criticism from Capitol Hill regarding his recent ultimatum to Israel, warning of a halt in some US weapons shipments in response to a potential major Israeli offensive in Rafah, CNN reported.

In a televised interview with CNN's Erin Burnett, Biden's declaration drew swift rebuke from lawmakers across the political spectrum. Republican Senator JD Vance of Ohio questioned the coherence of Biden's approach, pointing out the contradiction between expressing concern for Palestinian civilian casualties and withholding weapons designed to minimise such casualties.

"On the one hand, they're saying too many Palestinian civilians have been killed. With the other hand, they're depriving us of the precisionguided weapons that actually cut down on civilian casualties," Republican Senator JD Vance of Ohio told CNN though Biden specifically withholding mentioned bombs and artillery shells deemed by the administra-

"The Americans describe diplomacy as the best option... We are of the same view and are also ready to return to negotiations," Kamal Kharazi, foreign policy adviser to Iranian Supreme Leader Ayatollah Ali Khamenei, said on Sunday, as per state news agency ISNA.

During the past 24 hours. the Israeli army killed 63 Palestinians and wounded 114 others, bringing the total death toll to 35,034 and injuries to 78,755 since the Palestinian-Israeli conflict broke out last October, it said on Sunday as guoted by Xinhua news agency report.
