SUSTAINABILITY POLICY OF EKI

Environmental Reporting

EKI Energy Services will monitor and measure our environmental impact, and ensure compliance with relevant environmental laws and regulations. This will include regular reporting on our environmental performance and progress toward our sustainability goals.

Communication and Engagement
